



WILLIAMS HOUSE ADMISSION CONTRACT

Lindner Center of HOPE (The Center) appreciates the confidence you have shown in choosing us as your treatment care provider. Our patient and family-centered treatment philosophy requires that we openly communicate our policies and expectations about payment for our services before treatment is initiated. Please take a moment to familiarize yourself with this agreement prior to signing.

PAYMENT RESPONSIBILITY:

I acknowledge that I am financially responsible for all charges associated with services provided to the patient named below through the Williams House program. I understand that payment outlined below is due in full prior to admission to The Williams House program and full payment prior to the start of additional services. I understand that interruption of a program for a clinically determined medical condition will result in suspension of the program until such time as the patient is cleared to complete the program. Any medically determined inpatient stay is separately billable to insurance and the financially responsible party is responsible for any co-pay and deductibles under their plan. If insurance does not cover the inpatient stay the financially responsible party is responsible for payment at the self pay rate. Patient will be entitled to any remaining prepaid days of treatment. **For patients requiring additional staff due to higher levels of acuity or risk will be charged an additional daily fee of \$600.00.** Payment for the additional days must be received prior to the end of the original contract term. **I acknowledge the Williams House services are an elective self-pay treatment program. I understand I am financially responsible for the payment of these services.**
